PHYSICAL DEMANDS

When working within an office environment, must possess mobility to work in a standard office setting and use standard office equipment, including a computer; vision to read printed materials and a computer screen; and hearing and speech to communicate in person and over the telephone; ability to stand and walk between work areas may be required. Finger dexterity is needed to access, enter, and retrieve data using a computer keyboard or calculator and to operate standard office equipment. Volunteers occasionally bend, stoop, kneel, reach, push, and pull drawers open and closed to retrieve and file information.

When working out in field, must possess mobility to work in changing site conditions; possess the strength, stamina, and mobility to perform light to medium physical work; to sit, stand, and walk on level, uneven, inclined, or slippery surfaces; to reach, twist, turn, kneel, and bend, to climb and descend ladders; and to operate a motor vehicle and visit various City sites; vision to inspect site conditions and work in progress.

The job involves fieldwork requiring frequent walking in operational areas to identify problems or hazards, with exposure to hazardous materials in some site locations. Volunteers must possess the ability to lift, carry, push, and pull materials and objects averaging a weight of 40 pounds with the use of proper equipment. Reasonable accommodations will be made for individuals on a case-by-case basis.

- 5. Where there is a threat to public safety.
